

PRIVACY STATEMENT

Gamco is concerned with the privacy considerations of the visitors to and users of its web site, and here wishes to describe its policy and practices with regard to the same.

Gamco's web server automatically recognizes only each visitor's domain name, but not the visitor's individual e-mail address. Gamco collects the individual e-mail address of each visitor to its web site only when the visitor voluntarily provides the same, as when a visitor participates in survey information, and/or elects to identify its site/register itself with Gamco. Whether a visitor is identified only by its domain name, or is specifically identified by its individual e-mail address, Gamco in each instance collects information as to which pages on its web site (or which are made available through links provided on its web site) are accessed or visited, and also collects any information which is voluntarily provided by a visitor to Gamco.

Gamco uses "cookies" on this site. A cookie is a piece of data stored on a site visitor's hard drive to help us improve your access to our site and identify repeat visitors to our site. For instance, when we use a cookie to identify you, you would not have to log in a password more than once, thereby saving time while on our site. Cookies can also enable us to track and target the interests of our users to enhance the experience on our site.
